In addition, Manatee School of Arts & Sciences is providing on-going assistance to Ms. Earman so that she continues to support student achievement in your child's school.

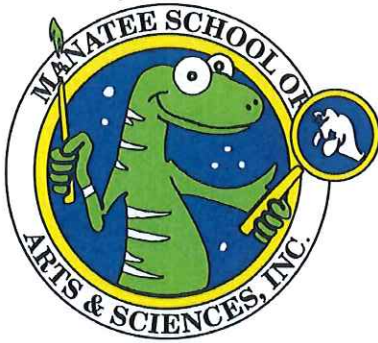

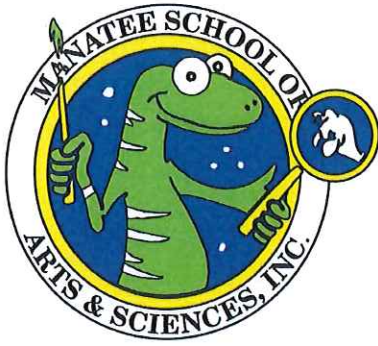
